- A Member desirous to exercise vote by Postal Ballot may complete this Postal Ballot Form and send it so as to reach the Scrutinizer, Mr. S Dhanapal of M/s.S Dhanapal & Associates, Practicing Company Secretaries in the enclosed postage prepaid self-addressed envelope not later than 5:00 p.m. (IST) on Saturday, July 28, 2018. Postal Ballot Form received after this date will be strictly treated as if the reply from such Member has not been received. Envelope containing Postal Ballot Form, if deposited in person or sent by courier at the expense of the Member will also be accepted.
- The Postal Ballot Form should be completed and signed by the Member, as per the specimen signature registered with the Company or furnished by National Securities Depository Limited (NSDL)/ Central Depository Services (India) Limited (CDSL), in respect of shares held in physical form or dematerialized form respectively. In case of joint holding, this Form must be completed and signed by the first named Member and in his/her absence, by any next named Member.
- An incomplete, unsigned, incorrectly completed, incorrectly ticked, defaced, torn, mutilated, overwritten
  or wrongly signed Postal Ballot Form will be rejected. The Scrutinizer's decision in this regard shall

- Members are requested not to send any other paper along with the Postal Ballot Form in the enclosed postage prepaid self-addressed envelope. If any other papers are found, the same will be destroyed by the scrutinizer.
- There will be one Postal Ballot Form for every Folio/Client ID irrespective of the number of joint Members.
- The Scrutinizer's decision on the validity of a Postal Ballot Form will be final and binding.
