Report on the Audit of Standalone Financial Results

Opinion

We have audited the accompanying statement of financial results of Wheels India Limited ("the Company") for the quarter and year ended March 31, 2025 together with relevant notes thereon ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ("Listing Regulations").
